Our History The WindsorEssex Community Foundation (WECF), originally founded in 1983 as Heritage Windsor, is a perpetual community trust for philanthropic purposes. It exists to manage donors' legacy funds and make grants to support local community programs. Through grant making activities, the WECF is able to establish partnerships to assist a broad range of community organizations. Over the past 33 years, the WECF has accumulated over \$12.3 million in assets and has granted \$5.9 million to a wide array of charitable programs, making a significant contribution to the lives of many in our community and building partnerships that last a lifetime. The WindsorEssex Community Foundation is a member of Community Foundations of Canada, joining 191 other community foundations across the country.

VITAL SIGNS









Vital Signs is a community report that's published annually by the WECF as an insert in the Windsor Star. The report combines survey results from the local community with provincial and national data to present an all-encompassing report on the quality of life in Windsor-Essex. INSPIRATION 100 TM



Inspiration 100 was launched in 2015 as an idea of Marty D. Solcz with the goal of assembling 100 community-minded people to commit to giving \$2,500 per year for 10 years, or \$20,000 upfront to create an endowment fund at the WECF totaling over \$2.5 million. All proceeds earned from investment of the fund are to be granted back to the local community. The inaugural meeting of Inspiration 100 took place in June 2016. RANDOM ACT OF KINDNESS DAY



For the fifth year in a row, the WindsorEssex Community Foundation brought Random Act of Kindness DayTM to the Windsor-Essex community. On November 6, 2015 the WECF joined many people and groups across the region as they celebrated kindness by engaging in various activities throughout the day. VITALITY LEGACY PROGRAM

The donation is never spent, ensuring your loved one's legacy lives on and your donation helps to fund charitable organizations today and forever.

THE YOUNG PHILANTHROPISTS



The WECF introduced the Young Philanthropists, a group of local philanthropic-minded youth who are passionate about making Windsor-Essex an even better place to live, work, play and grow. The Young Philanthropists meet monthly to engage in skills-building workshops, fundraising activities, and volunteering. The group held their own bake sale and Peer-to-Peer Campaign and have raised over \$2,000 to establish their own Youth Endowment Fund where proceeds will benefit youth-serving charities across Windsor-Essex.







Our Impact

WINDSOR YOUTH CENTRE



Last November the WECF provided a Community Impact Grant to the Windsor Youth Centre to support the Up2U Program--a relapse support group that operates within the community for youth. Up2U hosts weekly meetings with 15+ youth attending on a regular basis. One program participant is maintaining regular attendance at St. Clair College and another who experienced chronic homelessness has now maintained stable housing. The WECF is proud to support the Windsor Youth Centre and their on-going work to assist local youth.

DOWNTOWN MUSIC INITIATIVE



The Downtown Music Initiative (DMI) received a Fast-Track Grant from the WECF to support the DMI Strings Program. The WECF was able to assist the DMI with the purchase of 26 violins for their youth. The WECF is proud to support the DMI Strings Program and help improve accessibility to music education for local youth.

DOWNTOWN WINDSOR COMMUNITY COLLABORATIVE



Funds at the WindsorEssex Community Foundation

AGENCY FUNDS

Agency Funds allow area charities a safe and efficient way to establish their own endowment fund while benefiting from our investment and administrative expertise.

BURSARY & SCHOLARSHIP FUNDS

Bursary and Scholarship Funds allow donors to make lasting gifts recognizing student potential. The scholarship funds provided are directed to the college or university of the student's choice.

COMMUNITY FUND

Community Funds are composed of many gifts, large and small, each symbolizing a lasting investment in our region. Grants from these funds are awarded through our Community Impact and Fast Track grant programs, allowing us to respond flexibly to our communities' immediate needs and priorities. CIGs fall into seven categories: Health and Human Services; Arts, Culture & Heritage; Recreation & Sport; Environment; Education & Literacy; Children & Youth; and Community Development.

DONOR ADVISED FUNDS

Donor Advised Funds allow fund-holders to work closely with the foundation's grant making review committee to select projects and organizations that mean the most to them. They operate much like private foundations, but without the cost and administrative work for the donor.

DONOR DESIGNATED FUNDS

Donor Designated Funds allow donors to make lasting gifts to their favourite charities. With the establishment of a fund, donors select one or more charitable organization, local or national to benefit from their fund.

FIELD OF INTEREST FUND

Field of Interest Funds allow donors to identify a specific area of interest that they wish to support. Local grant recipients are determined by the foundation's grant making review committee, ensuring that the fund remains responsive to the community's needs while supporting the donor's interest.

MANAGED FUNDS

Managed Funds are established with the Community Foundation in order to benefit from the foundation's professional investment management.

FAST TRACK GRANTS

Fast-Track Grants provide up to \$1,000 in funding. Applicants for this grant are those that require funds quickly to either cover unexpected expenses that are preventing operations. Fast Track Grants are open for applications on an on-going basis throughout the year.


