

FAQ'S ABOUT ESTABLISHING AN ENDOWMENT FUNDS

IS THE DONATION TAX DEDUCTIBLE?

Yes, the WECF is a registered charitable organization. We provide our donors with tax receipts for their generous contributions.

WHO OVERSEES THE ENDOWMENT?

The Foundation Board oversees endowment investments, guided by the financial expertise of the Audit & Finance Committee, supported by WECF staff.

WHAT ARE THE MINIMUM ENDOWMENT LEVELS?

The minimum initial principal donation to establish an endowment is \$20,000.

WHEN WILL AN ENDOWMENT START PROVIDING FUNDING?

Payouts begin at least one year after creation, allowing the fund to generate revenue. Donors can contribute during this time to support payouts until the endowment becomes self-sustaining.

ADVANTAGES OF BUILDING AN ENDOWMENT FUND

TAX ASSISTANCE: WECF provides donors with maximum tax advantages.

POOLED INVESTMENTS: Your endowment fund will be pooled with other funds held at the Foundation allowing for a broader spectrum of investments, protection of capital, and increased returns.

FUND MANAGEMENT: The WECF manages all administrative and investment details, allowing you to focus on your philanthropic goals, with expert oversight from our Audit & Finance Committee.

CONVENIENCE: The WECF offers a "foundation within a foundation," providing all the benefits of a separate fund without the burdens of managing a private foundation. We handle everything from grantmaking support and recordkeeping to investing and independent annual audits.

FLEXIBILITY: Establishing a fund allows you to address multiple interests. The WECF supports a broad base of community projects and services including: health, education, youth, the environment, recreation, arts, culture, and community development.

INCREASED VISABILITY: The WECF has developed a strong reputation among community leaders and donors as one of the voices of community philanthropy. Establishing a fund with the WECF shows your commitment to a long-term sustainable mission. We are proud to actively support our fund holders and their philanthropic goals.

GROWTH OF AN ENDOWMENT FUND


This is an example of what your fund could look like over the next 10 years with an initial investment of \$100,000.

For the Hitchcock family, the DAF model has been the perfect vehicle to carry out their philanthropic vision.

You can add to your endowment at any time and receive a charitable tax receipt based on CRA guidelines. Disbursements can be made from your fund to registered charities on an annual basis.
